Accident Investigation:

On May 26, 2015 at approximately 7:18pm, the Hillsdale County Sherriff's Department was dispatched to 6480 E. Burt Rd., Ransom Township for an accident involving a tractor.

Investigation revealed that Clyde Leonard Town, age 84, of 6480 E. Burt Rd., Waldron, MI was traveling south bound approximately half mile north of E. Burt Road on his property. Town was operating a Case International loader tractor when it appeared that he got too close to a ravine and struck a wash out with the right front tire of his tractor, causing the tractor to roll over and down the ravine pinning Mr. Town causing fatal injuries.

Sheriff Deputies were assisted on scene by Hudson Ambulance, Woodbridge Fire and Rescue and the Wright Waldron Fire and Rescue. The accident remains under investigation.
