#### **Traffic Accident**

On June 5, 2015 at approximately 10:25pm, the Hillsdale County Sheriff's Department was dispatched to Hakes St, near Montgomery Rd., in Camden Township, for a one vehicle accident. Justin Richard Woodworth, Age 31, of 4039 N Pleasant Dr., Hillsdale, MI. was Eastbound on Hakes St, near Montgomery Rd when Mr. Woodworth's vehicle ran off the roadway to the right, and he lost control the vehicle ten overturned. Mr. Woodworth was ejected and transported to the Hillsdale Community Health Center by Reading Emergency Unit for injuries sustained. The Hillsdale County Sheriff's Department was also assisted by Montgomery Fire Department. Accident remains under investigation.

On June 6, 2015 at approximately 3:00pm, the Hillsdale County Sheriff's Department was dispatched to S Hillsdale Rd West of Bear Lake Rd., in Cambria Township, for a two-vehicle accident. Shane Edward Adoline, Age 16, of 8939 Sand Ridge Dr., Holland, OH; and passengers Cody Allen Wolff, Age 19, of 26821 Lakevue Dr., Apt1, Perrysburg, OH., Elliott-Todd Albert Boggs, Age 18, of 649 Wright Ave, Toledo, OH., and Adam David Grimes, Age 19, of 1261 Shelly Ave, Maumee, OH., were traveling westbound on West Bear Lake Rd when Adoline disregarded the stop sign at the intersection of West Bear Lake Rd, and South Hillsdale Rd. and proceeded through the intersection. As a result, Adoline was struck by Aaron Douglas Clark, Age 33, of 9300 Steamburg Rd, Hillsdale, MI., and passenger Joshua Michael McKibbin, Age 35, of 9375 Steamburg Rd, Hillsdale, MI., who was traveling Southbound on South Hillsdale Rd. Clarks vehicle, struck Adoline, the vehicles ran off the roadway with one vehicle rolled onto its roof. All subjects were wearing their seatbelts. No one involved in the accident was transported to the Hospital but they were checked out by Reading Emergency Unit. The Hillsdale County Sheriff's Department was also assisted by Hillsdale Rural Fire Department. Adoline was cited for failure to yield. Accident remains under investigation.
