On 10/6/15 the Hillsdale County Sheriff Dept. was dispatched to 4286 Long Lk. Rd, Reading, Mi. reference an Home Invasion and Unauthorized Driving Away an Automobile investigation. The homeowner advised upon her waking up around 430pm she noticed her purse was missing along with their TV, laptop and tablet, all missing from the living room. The homeowner also advised that her 2008 Chevy Colbalt was missing from the driveway. Deputies were advised that the vehicle had OnStar who was then contacted. Deputies working with OnStar, Lucas Co. Sheriff Dept. and the Toledo Police Dept. located the stolen vehicle in Toledo Ohio and a traffic stop was conducted. Driver the vehicle was Matthew Scott Kiss age 27 and the passenger was Joshua David Smith age 27, both from Toledo, Ohio. Detectives from the Toledo Police Dept. obtained evidence from the vehicle that belonged to the residents of 4286 Long Lk Rd, Reading, Mi. Arrest warrants were obtained by Hillsdale County Sheriff Dept. detective and both subjects were extradited back to the State of Michigan.

Matthew Scott Kiss and Joshua David Smith are currently lodged at the Hillsdale County Sheriff Dept. on Home Invasion 1<sup>st</sup> Degree, Conspiracy to Commit Home Invasion 1<sup>st</sup> Degree and Unauthorized Driving Away an Automobile.

The Hillsdale County Sheriff Dept. continued the investigation with their detective obtaining information that additional Breaking and Entering's were committed on Beach Dr., Reading, Mi. Information was obtained from the Toledo Police detective that both Matthew Kiss and Joshua Smith were staying at a family cottage belonging to Kiss's family on Cox Dr., Reading, Mi. The Hillsdale County Sheriff detective then contacted the Michigan State Police to see if they were investigating any Breaking and Entering's in the area of 4286 Long Lk Rd. The detective from the Hillsdale County Sheriff Dept. and Troopers from the Michigan State Police Jonesville Detachment obtained information that 5 additional Breaking and Entering's had occurred involving Joshua David Smith and Matthew Scott Kiss. A search warrant was obtained an executed on the Cox Dr. Cottage, with numerous stolen items seized from the other Breaking and Entering's on Beach Dr., Reading, Mi.

The investigation is continuing with the Toledo Police Dept. and other Ohio Police Agencies.

Additional arrest warrants are being sought by the Hillsdale County Sheriff Dept. and the Michigan State Police through the Hillsdale County Prosecutor Office.
