Accident Investigations

On June 23, 2016, at approximately 5:45 a.m., the Hillsdale County Sheriff Department was dispatched by Central 911 to Homer north of Borden Rd. in Scipio Township for a two vehicle property damage accident. Michael James Ryan, age 52, of 14420 W. Merry Dr., Camden, MI was operating a 2007 Mercury Milan northbound on Homer Rd. Ryan passed a 2001 Mercury Cougar, also northbound, driven by Travis James Clark, age 33, of 177 N. West St., Hillsdale, MI. Ryan re-entered the northbound lane close to Clark's vehicle, then braked hard for raccoons in the roadway. The vehicles collided and Clark's

vehicle went into the ditch. Both drivers were wearing their safety belts. No injuries were reported Ryan received a citation for careless driving.

On June 23, 2016, at approximately 7:16 a.m., the Hillsdale County Sheriff Department was dispatched by Central 911 to Pittsford Rd. north of Union Rd., Pittsford Township for a one vehicle personal injury accident. James Scott Stockford, age 32, of 1591 Holcomb Rd., Hillsdale, MI was operating a 2004 Ford four door northbound on Pittsford Rd. when he took his eyes off the roadway and left the roadway. Stockford hit a driveway culvert launching his vehicle into the air where it struck a tree on an embankment and then fell into a ditch rolling onto its side. Stockford and a minor passenger in the vehicle were transported to the Hillsdale Hospital for treatment of injuries. They were both wearing their safety belts. Deputy was assisted on scene by Pittsford-Jefferson Fire Department.
