FATAL INJURY CRASH INVESTIGATION

February 06, 2017

On Sunday February 05, 2017 the Hillsdale County Sheriffs Office was advised by the Washtenaw County Medical Examiner's Office that Roy Russel Signor 56 had passed away at approximately 4:40 pm at the University of Michigan Hospital.

Signor had been involved in a three vehicle crash on E. Chicago Rd just east of Halfmoon Lk Rd. in Fayette Township on Monday January 30, 2016.

According to accident investigators it was determined that Zeljko Radjenovic 48, of 11250 Glenis Dr. Sterling Heights, MI. was operating a Semi Tractor Trailer traveling east bound on E. Chicago Rd. when he crested a hill at Halfmoon Lk Rd and observed a white SUV stopped on the roadway attempting to turn left into a private driveway, Radjenovic struck the rear of the SUV driven by Roger Dale Jermeay 50, of 2040 E. Chicago Rd. Jonesville. Jermeay's vehicle was pushed into west bound oncoming traffic and stuck a Chevy Blazer driven by Roy Russel Signor 56 from Allen, who left the roadway and overturned with one passenger Cathleen Laverne Signor 44, who passed away at the University of Michigan Hospital on the day of the crash.

Jermeay was transported by ambulance to Henry Ford Allegiance Hospital in Jackson and has since been released. Roy Russel Signor was transported by Air Ambulance to University of Michigan Hospital. Cathleen Laverne Signor was flown by ST. Vincent's Life Flight to University of Michigan Hospital where she passed away.

The accident remains under investigation at this time. Deputies were assisted at the scene by members of the Jonesville and Moscow Fire Departments, Reading Emergency Unit Ambulance and Somerset Ambulance and Michigan State Police.
