Traffic Accident

On February 6, 2017 at approximately 10:00pm, the Hillsdale County Sheriff's Office was dispatched to S Hillsdale Rd near Dimmers Rd., in Woodbridge Township, for a one vehicle accident. George Forrest Brown, Age 32, of 10220 Woodbridge Rd, Camden, MI., and his juvenile passenger were traveling northbound on S Hillsdale Rd north of Dimmers Rd. Mr. Brown stated the vehicle's steering wheel went out of control spinning. Mr. Brown said he then went off the road and crashed into the ditch with the vehicle resting on its passenger side. The vehicle had a broken tie-rod forcing the vehicle out of control. Both Mr. Brown and his juvenile passenger had minor injuries and refused ambulance medical attention at the scene and sought their own medical attention. Accident remains under investigation.
