Accident Investigation:

On March 02, 2017 at approximately 7:26am, the Hillsdale County Sheriff's Office was dispatched to Litchfield Rd east of Hadley Rd in Litchfield Township for a one vehicle accident. Madison Marie Boyer, Age 17, of 1157 Clarendon Rd, Quincy, MI. was traveling east bound on Litchfield Rd, too fast for conditions and lost control of the vehicle on the icy roadway. The vehicle ran off the road and overturned into the ditch. Madison was wearing her seatbelt. The Hillsdale County Sheriff's Office was assisted by Reading Emergency Unit, Litchfield Fire Department, Litchfield Police Department, and Fricks Towing. Accident remains under investigation.
