Traffic Accident:

On March 13, 2017 at approximately 11:10am, the Hillsdale County Sheriff's Office was dispatched to S Hillsdale Rd near Bear Lake Rd., in Cambria Township, for a one vehicle accident. Katelyn Elizabeth Seals, Age 17, of 3060 Long Lake Rd, Reading, MI. was traveling South bound on S Hillsdale Rd when due to the slushy/snowy road conditions she lost control of her vehicle. The vehicle then left the roadway, struck a set of mailboxes and then went into the ditch and rolled over on its roof. Katelyn was wearing her safety belt. The Hillsdale County Sheriff's Office was assisted by Hillsdale Tow, Hillsdale Rural Fire Department, Hillsdale City Fire Department, and Reading Emergency Unit. Accident remains under investigation.
