Traffic Accident

On March 25, 2017 at approximately 8:52am, the Hillsdale County Sheriff's office was dispatched to Chicago Rd, near Prentiss St., in Allen Township, for a two-vehicle accident. Rosemarie Whipple, Age 65, of 6200 Brown Rd, Jonesville, MI and passenger Diane Marie Linder, Age 66, of 615 Cone Ct, Jonesville, MI. was traveling westbound on Chicago Rd when another vehicle driven by William James Rembowski, Age 64, of 164 W Chicago St, Allen, MI. pulled out from the stop sign right in front of Whipple. Rembowski said he did pull out in front of the other vehicle but he thought it was going to slow down. Rembowski was cited for failure to yield the right of way. All 3 subjects were transported to Hillsdale Hospital for injuries sustained. The Hillsdale County Sheriff's Office was assisted by Allen Fire Department, Reading Emergency Unit and Life Care. Accident remains under investigation.
