Traffic Accident

On April 24, 2017 at approximately 12:15am, the Hillsdale County Sheriff's Office was dispatched to Crampton Rd near E Montgomery Rd for a one vehicle accident. Zachary James Annis, Age 22, of 3700 S Lake Pleasant Rd, Osseo, MI was traveling South Bound on Crampton Rd near E Montgomery Rd when Annis lost control of his vehicle and ran off the roadway to the right failing to make the curve and struck 2 trees before the vehicle came to a rest. Annis was able to drive the vehicle home then sought his own treatment at Hillsdale Hospital for injuries sustained in the accident. Annis was not wearing his seatbelt. The accident remains under investigation.
